

The following terms and conditions apply to all Golf4Fun events

- 1. Bookings will not be final until full payment is received. Receipt of payment constitutes full agreement to all terms and conditions stated.
- 2. The full specified payment shall be paid to confirm your booking prior to your event. Failure to do so may result in loss of reservation and cancellation charges applying as per clause 4.
- 3. Payment Terms
 - The full amount on the invoice delivered to the provided email address must be paid prior to the event. All fees must have been paid before commencing play.
- 4. Cancellation Terms
 - Cancellations, no shows and shortfalls will not be refundable.
- 5. Refund policy
 - Refunds and credits are not available for delays on the course due to slow play or poor weather conditions. No concessions or refunds will be made for any other poor weather conditions, however Golf4Fun may choose to reschedule the event to a more appropriate day.
- 6. All prices/charges are inclusive of VAT unless specified. If the rate of VAT increases, Golf4Fun has the right to change prices accordingly.
- 7. All participants are required to arrive at least 15 minutes before their arranged tee time. No refunds or credits will be given for participants who arrive late for their tee times
- 8. All participants must sign an indemnity form before commencing play
- 9. No inflammable, dangerous or offensive article or any animal (other than registered guide dogs) shall be brought onto the premises without written consent of the venue and Golf4Fun.
- 10. No person under the age of 18 shall be permitted to obtain or consume intoxicating drinks.
- 11. Golf4Fun reserves the right to conclude any event which, in its opinion, is unsuitable or not properly conducted and in such cases, no part of the payment shall be returned whatsoever.
- 12. . Golf4Fun shall not be liable, whether in contract, tort or otherwise for any personal, indirect, consequential or economic losses however arising, including those arising from services or products supplied by third parties.
- 13. Prices quoted on our website and other marketing material are subject to change
- 14. These terms and conditions shall be governed by the laws of South Africa

Terms for hiring equipment from Golf4Fun

On collection of your rental golf clubs you must provide your booking reference number.

- 15. **Payment:** All equipment must be paid for in full before collection. All rates listed on the website and the equipment desk are in Rands, and are subject to change without notice, although once a reservation has been confirmed the agreed price will be honoured. All rentals and purchases will be made via pre-booking on the website or in cash at the event. The agreed rental amount, any amounts due plus any late, lost, stolen, broken, non-returned equipment, and for all other amounts shall be payable under the terms and conditions of this Agreement.
- 16. **Subject to Availability:** Golf4Fun will make all reasonable efforts to provide you with the Golf Rental Equipment you ordered. However, please note that due to unknown factors such

- as Rental Equipment not being returned on time, insufficient Lead Time, lost or stolen equipment, etc., all of our Rental Equipment is subject to availability.
- 17. **Cancellations/No Shows:** All cancellations must be received via e-mail. Any cancellation within 2 days prior to the event will be non-refundable. Prior to this the full amount is refundable. Golf4Fun Rental equipment that is scheduled to be collected or delivered will be kept for 2 hours after the start time of the event, after this time the reservation will be classed as a No Show with the full rental amount forfeit.
- 18. **Pick-up/Drop-off Point:** All Rental Equipment must be picked up and dropped off at the Equipment desk. No exceptions will be made. Renters are asked to return equipment as they complete their round of golf and register their scores.
- 19. **Repossession of Rental Equipment:** We reserve the right to request the return of the rental equipment or to repossess the same at any time and for any reason. This is particularly the case if the equipment is being used unreasonably, carelessly, in a manner that violates the law, violates the terms of this agreement, or if the equipment appears to be abandoned.
- 20. **Failure to Return the Equipment**: You are obliged to return the equipment to us at the end of your 9 holes or upon our demand if we demand the return of the equipment sooner. Your failure to return the equipment to us for any reason, including if the equipment was lost or stolen may result in our charging you R250 per club for the equipment, in addition to any charges for the rental period.
 - The renter will not sell, assign, sublease or transfer any of the renter's interest in this Agreement or the Rental Equipment. Any such attempted sale, assignment, sublease or transfer is void and of no effect, and Golf4Fun shall have the right to immediately repossess the rented equipment and assess any applicable charges as specified in this Agreement.
- 21. **Purchasing equipment**: Golf4Fun provides only advisory services to clients wishing to buy clubs. Golf4Fun shall not be held responsible for any misrepresentation or failure to perform on the part of the recommended retailer.
- 22. Warranty Disclaimer: The equipment is rented on an 'AS IS' 'WITH ALL FAULTS' basis. You the renter agree to bear the entire risk as to the quality or performance of the equipment. Should the equipment be returned defective, the renter will assume the entire risk. Golf4Fun has not made, does not make, and hereby disclaims any representation or warranty whatsoever, expressed or implied, with respect to the rental equipment, including, but not limited to, its design, performance, condition, merchantability or fitness for use for any particular purpose. The golf clubs provided are original manufacturers clubs.
- 23. **Force Majeure:** Golf4Fun shall not be deemed to be in default of this Agreement if its performance is delayed or prevented by acts of God, public enemy, war, civil disorder, fire, flood, explosion, riot, labour disputes work stoppage or strike, any act or order of any governmental authority, or any other cause beyond the control of our company.
- 24. **Miscellaneous:** Any change in this Agreement must be in writing and must be signed by the parties hereto. Renter does not acquire any ownership or other interest in the Golf4Fun Rental Equipment except as specifically set forth herein. This Agreement constitutes the entire agreement between the parties.
